## **NCHRF Decries Forced Expulsion Of** Belgian

ome government officials in the Northwest and at the central administration (DGSN, DGRE) and Belgian Embassy, have been indicted for orchestrating an act of forceful and illegal repatriation of a Belgian human rights defender, Jan Joris Cappelle.

According to a report of a finding carried out by the National Commission for Human Rights and Freedom, NCHRF, this Belgian was not only illegal ly expelled from Cameroon, he was arbitrary arrest-ed, detained abusively, and faced numerous trumped up charges in an act of criminalization of

his work as human rights defender.
The report alleges that he was subjected to an illegal arrest, torture and detention at 10 District Police cell in Yaounde.

The Divisional Officer of Mbengwi is allegedly to have ordered the destruction of Tudig Community Organic farm and a pilot demonstration farm owned by Jan Joris Cappelle. The crops were declared as paddock for cattle.

The NCHRF report indicts some interest groups

as complicit in the gross human rights violations.

This condemnation on the abuses of the rights of the Belgian citizen who was still enjoying his legal residence permit, has drawn the attention of several international and national rights groups among which are Amnesty International, the Observatory for the Protection of Human Rights Defenders and the Yaounde based Centre for Environment and

The latest publication from these human rights groups came on January 18 2019. Given that the Regent of the Fon of Tudig and two of his subjects connected in the pilot phase of the new farming methods, were also arrested and case pending in court, these Rights Groups had filed a complaint to NCHRF denouncing that, these were acts of intimidation against members of a defence group on environmental rights in the Northwest of Cameroon. NCHRF report from enquiries carried out by the working group on civil and political rights, states the gross violation of the rights of the Belgian human rights defender and those of the Regent of Fon of Tudig, Vincent Awazi, Awazi Mathias and Humfred Manjo in violation of both national and international legal instruments on the protection of human rights.

Mr. Jan Joris Capelle, a Belgian Consultant on Mr. Jan Jons Capelle, a Belgian Consultant on agriculture and best practice on how to develop Community organic farm, was invited to Cameroon by the Fon of Tudig who is based in the USA, on behalf of that Community in Momo Division. NCHRF report states that the Belgian national

was issued a one year residence permit number 1181683605 on July 21, 2015. With the collaboration of the entire community, an organic farm was set up for the community and another pilot experi set up for the community and another pinc experi-mental farm was setup on a purchased piece of land of about four hectares and owned by the Belgian. He was President of the Organic Farming for Gorillas Cameroon (OFFGO) Association and Human Rights Defender. This Association's formal-ization process is said to have suffered several delays at the office the DO of Mbengwi for reasons

delays at the office the DO of Monegwi for reasons which were later discovered as protecting a hidden interest group against the project in Tudig.

According to the findings of the NCHRF, the local administrative and judicial authorities produced multiple trumped up charges against human rights defender Jan Cappelle. The report identifies intentional bad behavior in their actions. The NCHRF defines the motive of the expulsion "control

The charges against Jan Cappelle followed closely in reaction to a September 2015 report from traditional communities to the Governor of the North West Region about land grabbing. The Chief of Tudig village requested Jan Cappelle to assist with

the writing of the report.

The NCHRF calls for the authorities involved in the human rights violations to be brought to justice. The NCHRF found out that those interest groups are made up top elite and businesmen, complicit in the gross human rights violations. The NCHRF adds that it has received numerous complaints against these interest groups who are in to land grabbing which is the immediate cause of the several con-flicts in the Northwest. It therefore calls for an official investigation into all the land disputes in the


## Lebialem Community Communes With PM Dion Ngute
